Attached is EML Payments Limited's (**EML**) appendix 2A in relation to the issue of 4,869,323 fully paid ordinary shares.

The shares will be issued to the vendors of shares in Presend Nordic AB (now called EML Payments AB), which became a wholly owned subsidiary of EML on 1 February 2018.

The shares will be issued in satisfaction of EML's obligation to pay the vendors an earn out (in the form of EML shares) on the Presend business achieving sustained financial performance over a 2 year period to levels set out and agreed in the share purchase agreement.

EML is pleased to confirm that agreed financial performance was exceeded over the period.

The shares will be issued by reference to EML's share issue capacity as at 1 February 2018, the date it entered into the share purchase agreement to acquire Presend Nordic AB.

### Secondary Trading Notice per section 708A(5)(e)

In respect of the shares issued to the Presend vendors, EML gives notice pursuant to section 708A(5)(e) of the *Corporations Act 2001* (**the Act**).

The shares are issued without disclosure to investors under Part 6D.2 of the Act.

EML confirms that as at the date of this notice, it has complied with:

- (a) the provisions of Chapter 2M of the Act as they apply to EML; and
- (b) section 674 of the Act.

Further, as at the date of this notice, there is no information to be disclosed which is excluded information of the type referred to in sections 708A(7) and 708A(8) of the Act.

EML notes that in the ordinary course of its business, it continually evaluates growth opportunities, some of which may prove to be material and therefore price sensitive. As at the date of this notice, no such evaluations are sufficiently certain or material to require disclosure to the market.
